Subj:-

Grant of recognition to the school from class I-VIII (Without aid) w.e.f. academic session 1984-85 for a Day school (Single Shift).

Sir,

With reference to your application on the subject cited above, recognition to your school is granted from class I-VIII (without aid) w.e.f. 1984-85 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of Pitampura.
3. That the school shall appoint full time qualified and eligible staff for all classes of the school as per the present norms of the Department.
4. That the school shall equip the Science Labs as per the norms of the Department and suitable facilities for practical work shall be provided to the students.
5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and facility of reading room may also be provided immediately.
6. That adequate sports material shall be purchased and made available to the students immediately.
7. That the school shall strictly abide by the provisions of Sec. 10(1) of Delhi School Education Act & Rules, 1973.
8. That the enrolment in section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the classroom and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of the existing sections should not exceed to the number of classrooms of proper size in the school.

9. That the school shall not run any preprimary and unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place. Nursery class be removed from the premises of the school, if any. And no Branch of this school shall be run under the banner of the recognised school.
10. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
11. That the scheme of management shall be got approved from the Department immediately.
12. That service contract between the management and the employees shall be executed immediately.
13. That all the facilities prescribed under Rules 50 & 51 of the DSER, 1973 shall be made available to the students. Provision Rules 6, 7 and 9 be strictly observed.
14. That the arrangements for good drinking water shall be made available to all the students as well as to teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the local body within a month.
15. That the management of the school shall create a reserve fund of Rs.5,000 (Rupees Five Thousand Only) in a joint account in the name of the Director of Education and the Manager of the school in any scheduled bank within a month.
16. That the violation of any instructions/orders/conditions/rules and regulations of the Department shall lead to the withdrawal of recognition of the school. That class IX shall not be added to the school without the prior permission of the Director of Education, Delhi.
17. That the management of the school will construct a new building on the land allotted by the D.D.A. to the Department as per the specification of the Department and the school will be shifted to the new site within a period of 2 years with the approval of Department.
18. That no development fee shall be charged from the students.
19. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled, shall be sent to the Education Officer every six months.
